THE ORGANIZATION

The National Odometer and Title Fraud Enforcement Association (NOTFEA) is an association that provides a medium through which law enforcement, consumer protection agencies, licensing and motor vehicle departments, regulatory agencies, the automotive industry and individuals interested in deterring odometer, rebuilt, salvage and title fraud receive educational training at annual conferences, networking, exchange information and cooperate in matters of auto fraud related issues.

NOTFEA membership consists of individuals working for government law enforcement, consumer protection agencies, licensing and motor vehicle departments, and government investigators who are responsible for detecting, deterring and prosecuting odometer, salvage/rebuild and motor vehicle title fraud under state, federal and other applicable regulations.

NOTFEA is governed by a board of Directors. NOTFEA members meet at the annual conference. The annual meetings feature training on techniques for investigation, available resources, information on managing and preparing cases for litigation, as well as informative seminars on important auto fraud topics. NOTFEA members also share information concerning current trends and new legislation. Access to the NOTFEA website, roster, conference binder, and Auto Fraud Investigation Resource Manual is available to all paid NOTFEA members.

In the event that you cannot attend a conference we have created a non conference attendee membership so you can still have access to the website, roster, conference binder, and Auto Fraud Investigation Resource Manual. The fee is only \$25.00 per year. What a great opportunity to become or stay involved with NOTFEA even if you cannot attend a conference!

Any individual who qualifies for membership, pays non conference attendee dues of \$25.00, and abides by the Bylaws of the National Odometer and Title Fraud Enforcement Association shall be a member. You will be contacted via email* with a code to access the NOTFEA website once your membership is approved (*note – this approval may take 2-3 weeks).

Associate Membership - Must contact nhumphrey@notfea.org for membership information. At this time Associate Members will not have online access but can participate at a NOTFEA conference, once they are approved for Associate membership.

Associate Memberships are: Persons who do not qualify for active membership but who represent an organization, business, company or philanthropic endeavor known for objectives consistent with those of NOTFEA and who contribute a sum of money to the Association annually in a sum not less than that of current registration fees, are eligible to become associate members. Acceptability of an associate member shall be determined by the Board of Directors, after examination of the qualifications and suitability of such person to become a member of NOTFEA. Associate members shall have the privileges of any active member, except holding office or sitting on the Board of Directors. The Board of Directors may at its discretion exclude associate members from any particular topic, program or training session pertaining to confidential law enforcement information.
